At the request of Washington County Probation and Parole I conducted a Sexual History Polygraph Examination of Richard [REDACTED]. This examination was conducted at 5933 NE WinSivers Dr. in Portland, OR. 

After I drafted questions for the chart recordings, we discussed each question Mr. [REDACTED] would be asked. For the purpose of this exam "sexual activity" was defined as anything sexual involving another person where there was no direct physical contact involved. Examples would include but are not limited to phone sex, sexting, internet sex involving chatrooms or webcams, voyeurism and/or exhibitionism. Because of a lack of physical involvement (known or unknown) by the other party, "sexual activity" would not include dreams, fantasies, or the viewing of pornography. Mr. [REDACTED] stated he understood the wording and meaning, and agreed to each question in their form.

The polygraph components were attached to Mr. [REDACTED] and using the Air Force Modified General Questions (PL) Test format, I recorded four polygraph charts, asking the Relevant Exam Questions listed on page one, in various order.

At the conclusion of the examination I reviewed each chart and found there was No Significant Responses Indicated. As a result, it is my opinion Mr. [REDACTED] was truthful as he answered "No" to the Relevant Exam Questions listed on page one. My opinion and conclusions were verified using the OSS3 Algorithm.
